Pursuant to the FIM Sporting Code, the participant in an FIM Championship or Prize event or an international event exonerates the FIM, the FMNR, the CONUs, the FIM promoters, the organisers and the officials, their employees and officials, their employees and officers and agents from any and all liability for any loss, damage or injury which he may incur in the course of an FIM Championship or Prize event or international event or the practice for such event.

Furthermore, the participant undertakes to indemnify and hold harmless the FIM, the FMNR, the CONUs, the FIM promoters, the organisers and officials, the employees, officers and agents, from and against any and all liability to third parties for any loss, damage or injury for which he/she is jointly and severally liable.

Final decisions handed down by the jurisdictional bodies or the General Assembly of the FIM shall not be subject to appeal in the ordinary courts. Such decisions must be referred to the **Court of Arbitration for Sport (CAS)**, which shall have exclusive authority to impose a definitive settlement in accordance with the Code of Sports-related Arbitration.

The team has read and understood unreservedly to be bound by the FIM Regulations, FIM Medical Code, FIM Ethic code and the FIM Antidoping Code.

## **NOTE FOR THE USE OF PASSES**

The FIM passes are permanent passes and valid for the current year. They are numbered and bear the name of the company to which they have been issued.

All passes are valid for the personal use of the employees of the company or persons authorised by the latter giving the right of access in reserved areas, as defined in the respective sporting appendices, and must permit their holders to accomplish their professional obligations in an efficient manner.

The holder must comply with the FIM regulations and to the decisions taken by the International Jury/Race Direction. Improper use of these passes will result in its immediate withdrawal. Should the holder encounter difficulties in carrying out his professional duties, he must consult the Clerk of the Course in the first instance, and if necessary, the Jury President/FIM Delegate.

**NOTA BENE:** The passes must be presented to the organiser of the event. It is advisable to inform the organiser in advance stating the number of the FIM licence in order to facilitate obtaining the organiser's passes before the event.

The passes give the right of access to areas reserved for the public. Not including: the pit area (the track in front of the pits) and track side.
