### International TRIAL Championship of Slovakia SMF Cup for Youth and Hobby class

- 1. The competition** is organised according to the National Sporting Code of the SMF for Trial, valid for 2013 and these Supplementary Regulations. The race can be attended by holders of FIM and FIM Europe (UEM) licence, holders of SMF licence type A or B for trial or one-event licence. Foreign riders associated in other National Federations can start with own valid licence together with a start permission. The event is announced for groups A, B, C – international championship of Slovakia and for class children and free as a SMF cup.
- 2. Categories colour markings:** A – yellow; B – green; C – red; Free – white; Children – blue
- 3. Venue of the event:** Lazy pod Makytou  
GPS: 49.211878, 18.212754
- 4. Date of the event:** **31.08-01.09.2013**
- 5. Track** leads outside of public roads, the length of one lap is 15 km, one lap has 10 sections and 3 laps for all categories. Total riding time is 300 minutes.
- 6. The event** is covered by SMF third-party liability insurance, however each rider will confirm by signature on the Technical card, that he is insured according to the National regulations of SMF. The organiser doesn't undertake any responsibility for any possible damage and losses occurring in relation to competitors and their equipment as well as directly or indirectly to third-parties and their property.
- 7.** According to the valid general rules of SMF, riders without driving license are not allowed to ride bikes outside the race course.
- 8.** Administrative and technical control will be done according to the regulation NO52,1 of the SMF National sporting code.

**12. Environmental regulations:**

- Washing of the motorcycle is permitted only in the designed area – without any chemical substances
- Pouring or throwing away used oil or any other petrol waste outside the marked boxes is forbidden.
- The rider and his team have to use the environmental mat (1,6x1 m) by parking, repair works, refuelling and under the waste boxes. The environmental mat must be composed of an absorbent part (upper part) and an impermeable part (bottom part).

These directions are mandatory. Any infractions of these regulations may be penalised – 33,-€.
