III. GENERAL CONDITIONS

This Competition will count for:

- The 2021 FIA European Autocross Championship
- The 2021 FIA European Cross Car Championship
- The 2021 FIA Autocross Nations Cup
- The 2021 FIA Cross Car Academy Trophy

a) DESCRIPTION OF THE CIRCUIT

Location: 27 km from Olomouc in direction to Přerov – Čekyně

b) ENTRY FORMS – ENTRIES

Anybody wishing to take part in the Competition register from the FIA website www.fia.com

The maximum number of starters will be 120.

c) ENTRY FEES

The entry fee is:

- 1st closing date of entries: maximum 220 € (Entry fee 170 € + 50 € paddock fee – all included)
- 2nd closing date of entries: maximum 275 € (Entry fee 225 € + 50 € paddock fee – all included)
- After 2nd closing date of entries: maximum 440 € (Entry fee 390 € + 50 € paddock fee – all included)

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

The entry fee will be paid before (08/08/2021), closing date for entries:

- **(08/08/2021)**, 1st closing date of entries
- **(16/08/2021)**, 2nd closing date of entries

d) Entry fees may be refunded only:

- to candidates who are not accepted,
- in the case of the Competition not taking place,
- if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.



IV. INSURANCE

- a) The frame insurance contract No. 400046134 concluded by and between the Allianz pojišťovna, a. s. and Autoklub CR includes insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.
- b) Organiser concluded additional contract against damages caused to third persons up to the sum of € 10.000.000.
- c) Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

V. NOISE CHECKING

For all cars, a limit of 100 dB is imposed.

VI. PRIZES AND CUPS

e) COVID – 19 PROTOCOL

In the context of the COVID – 19 pandemic, the primary responsibility sits with the event organiser to ensure that any national, regional or local laws, regulations, policy, guidance or advise issued by the competent authorities in the territories relevant to the event are complied with at all times. Drivers and Competitors must commit to follow the instructions of the Appendix S to the ISC and of the latest release of the event COVID – 19 protocol published by the event organiser on the website www.ak-prerov.cz and to any additional local instruction brought by the organizer to comply with the local sanitary regulations.

f) TYRES FOR WARM UP

SuperBuggy, Buggy1600 & Cross Car European Championship: Tyres not registered for this event can be used during the Warm-up session. They must be of the make and type defined in the sporting regulations.

g) RADIO CROSS CAR ACADEMY TROPHY

Modification of Article 7.5 of Cross Car Academy Trophy: Radio communications between Teams and Drivers is prohibited.

h) START PROCEDURE

11.1.1 Start procedure: the start procedure begins with showing a board "READY to RACE" sign on a light panel. After this, the start will be given when the green light is switched on.

There must be an electronic system for each start line and there must always be a margin of 15cm +/- 5cm between the electronic system (or the start line) and the car. The use of a camera recording the starts is obligatory. On each row will be a camera.

i) ARTICLE 279B - POINT 4.12 – APPENDIX J – INTAKE MANIFOLD

Correction to the French version of point 4.12 of Article 279B of Appendix J to the International Sporting Code.

4.12 Collecteur d'admission

Homologué.

Il est possible d'adapter, sans toutefois changer la forme intérieure de la boîte à air du collecteur d'admission, un ou 2 tuyaux à seul but de connecter des filtres à air extérieurs.

Le filtre à air original peut être enlevé.



4.12 Intake manifold

Homologated.

It is possible to adapt, without changing the internal shape of the intake manifold, one or 2 pipes in order to connect external air filters.

Original air filter may be removed.
