SUPPLEMENTARY REGULATIONS (SR's) 2024

These SR's must be issued by the FMNR responsible for organising the event, and be in accordance with the FIME Sporting Code, with the event being held under the FIM Europe and FIM rules applicable for Track Racing.

An Environmental Management Map (EMM) of the venue <u>must be sent together with a draft of these SR's</u>. Once the EMM has been approved by the FIME Environmental Commission, the FIME Track Racing Commission (FIME TRC) will ensure that a copy is distributed to all participants.

If the organising club/promoter is planning to have the event filmed for either television broadcasting or live streaming, THEN PERMISSION MUST FIRST BE SOUGHT from the FIME TRC.

Copies of these SR's <u>must be sent to the FIME Track Racing Chairman</u> (<u>trcfime@gmail.com</u>) for approval at least TWO months (SIXTY days), before the date of the event. Once approved, the SR's will be sent to the FMNR and the FIM Europe General Secretariat.

The use of environmental mats <u>is COMPULSORY</u> If competitor's use a generator or other similar petrol/diesel engined devices within their pit area, then they too must be placed on an environmental mat to ensure that no spills or leakage seeps into the ground.

<u>Payment of Expenses Reimbursement:</u> Expenses Reimbursement will be paid at the end of the event: <del>YES\*</del> / **NO** (\*delete as applicable).

<u>Protests and Appeals</u>: All protests to the International Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of the FIM Europe and be accompanied by a fee of **350 Euros or 8500 Kč** (*state amount and currency*) to the exchange rate of the Friday prior to the event.

<u>Race format:</u> After 20 heats of the official programme, the first five riders will enter the final heat 21. The final heat is run on 5 laps with a five riders. Positions 1st to 5th in the Final Meeting Classification will be according to the Riders finishing positioning in the Final Heat (the winner of the final is winner of the whole meeting).

If after the 20 heats there is a tie of points among the first five riders, the order will be determined by 2024 TRA FIM art. 11.3 (Ties).
